

MAKE CHANADA GREAT AGAIN CONSTITUTION.

ARTICLE: I

Section 1. Definitions.

The Senate: Consists of the current leadership of the various Chanada states.

Emperor: Head of the Federal council.

Federal council: Up to 3 Representatives of each state, under the emperors council.

Section 2. Role of the federation

Federal powers: *Foremost, the creation of the state.*

For the creation of a federal state, at least three powers are needed. All holding one vote from each nation's leaders. Three nations are needed so a hung vote in a council is not met. Any laws or agreements will be scraped if less than three powers vote. As the federal state will put forward an issue that needs to be dealt with. Three votes is also equal to three arguments and a conclusion.

Starting a federation and council: Starting off, the nations of /K/ompound, /Pol/yneisa, and Neustria will be delegated one vote each for a head of state under the Senate

Election of a head of state, and Senate members.

1. A senator is one representative from a nation. Preferably the leader.
2. Senators are unable to apply for the federations leader.
3. The first leader of the Federation will be elected by the leaders, or in the council's case, the senators.
4. The head of state must be an active player on civcraft and a citizen of former Chanada.
5. The head of state has an unlimited term. But can be overruled and hence overthrown by the nation states as a collective. The balance of power will always favour the nations.
6. To relinquish leadership you must name a successor.

Purpose of the Federal state.

The federal states primary purpose is to protect the collective nations in the Chanadian federation under military supervision. The secondary purpose of the federation state is to inspect, allow, or decline any applications in becoming a member state of the council. The third purpose of the federation state is to uphold any passing laws and prohibitions. The fourth power is to create, present, and arrange the discussion of issues with-in Chanada. The fifth power the state will uphold is as the figure and announcer to reddit. No single nation can suggest, propose or retract an official statement on behalf of Chanada. Finally, the Federal state exists to provide democratic directives concerning the collective states beyond a purely defensive position.

Clarification of delegations and requirements of upholding federal powers.

To apply for membership of the federation, you must be a pvper or hold a considerable amount of wealth. The federal states leader holds one vote and one argument in the council. Member states of the federation are permitted to have a military to prevent any means of the federal state from going rouge. To make sure that the federation upholds its promise to Chanada.

ARTICLE: 2

SECTION: 1 Type of government.

The Chanada Congress is a bicameral legislature of the federal government of Chanada consisting of two houses: the Senate and the Council of the Federation. The congress meets on google docs to debate, propose amendments, and vote. The meeting is to be made public on 8chan /civ/ for transparency and public discourse except for matters of national security.

SECTION: 2 Legislative Branch, (Expanded definitions and powers)

The Senate: Consists of the current leadership of the various Chanada states. Each member only has one vote.

Federal council: Up to 3 Representatives of each state, under the emperors council.

(See section 4 for criteria)

SECTION: 3 Executive Branch

The Emperor: Elected by the Senate and is considered the Chairman of the Council. The Emperor can be recalled if the Senate votes it so. The Emperor's primary role is to keep order in government and for diplomatic relations outside of Chanada.

In a time of civil emergency. The Individual states may deal with the situation at hand, and a discussion will be held in response with the federal council. The federal council may or may not step in to resolve the emergency; as will be decided by vote. (However, if the issue affects a nation's sovereignty, or people, it then becomes a national issue)

In a time of national emergency. The emperor has the ability to command the union up to the Senate's reach. The Senate may assign a solution to deal with the emergency as soon as possible.

SECTION: 4. State Creation.

For a nation to apply for the senate voting, it may have the following qualifications:

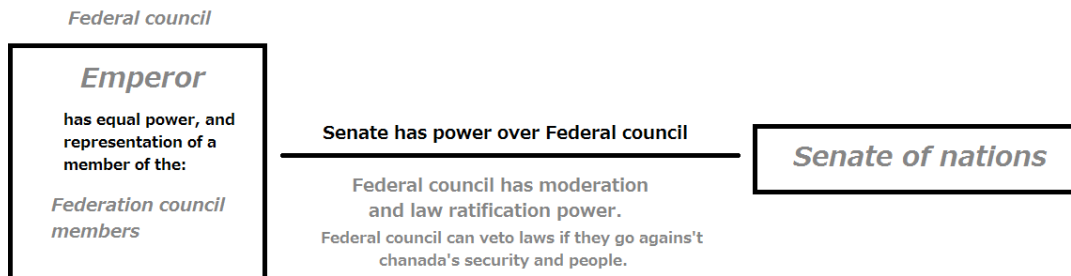
1. The nation has at least six people who log on at least weekly and contribute.
2. The nation has at least 2000 diamonds of assets in the form of iron, diamonds, tools, prot, and factories.
3. The nation has the ability to defend itself against attackers and has basic vaulting and snitch systems.

If a nation does not meet these requirements, it can still apply for membership statues - *to which exceptions can be made*. However, it will be up to the Emperor and the Federal council to approve/disapprove of it, and in most cases it will be disapproved.

Votes in the Federal council: After a nation has entered the senate, they must allocate between 1 and 3 representatives to be appointed or elected, to the Federal council under the Emperor, nominations are as each state sees fit. Each will delegate and have a single vote in the council.

Emergency Power Clause: The Senate may appoint figures to act upon their own discretion in times of need where applicable (as temporary/provisional replacement for current senate members) . The reach of any given figure cannot

extend beyond the reach of the senate, determined upon the figure's appointment; and serves merely as a decision maker when fast responses are necessary. As soon as the necessity for the figure is gone, outlined upon the figure's creation, the figure ceases to hold any of the senate's power.

SECTION: 5. Procedure of voting and issue proposal.

Procedure: The Council of the Federation are the first to meet, propose laws, debate, and vote. The Emperor will act as a moderator and keep the council in order. In the event of a tie the Emperor can serve as a tiebreaker.

Proposals and votes: A proposal may be made by any representative; and hence originate from any person represented; at any time. Before making it official; it is recommended that it be discussed among representatives before being submitted to the proposals document.

When a proposal is conceived and in its final written form, it may be submitted to a document with a timestamp. From this moment; there is a precisely 1 week period until discussion and voting on the proposal ends.

In the 1 week period representatives may receive directives from their respective states; take internal votes; or otherwise manage the state's vote as the state's political system dictates, provided that the representative can bring the state's vote to the council before the week is up.

Vote counting: Each vote must be timestamped, and be made before the 1 week period is over. Votes cast after this time are not counted.

There is no minimum for a vote to pass; it must merely reach a majority among the counted votes. Any state which does not vote will be counted as abstention.

Voting and issues will be organized weekly. Access to comment, and edit a google doc discussion will only permit Senate leaders, and federal council members.

ARTICLE: 3

Admittance, and rejection from Federation.

Admittance to Chanada: Each Nation wishing to enter the union of Chanada must apply to the Council of the Federation. After the federation has approved this, the invitation must be approved by the Senate in a case-by-case basis. A supermajority is required for acceptance into the union.

Ejection from Chanada: At any time it seems necessary for the removal of a nation from the union, a vote must be held by the Senate. However, a supermajority is required in order to expel a nation from the union; and may be overruled by the Emperor at the time.

Alteration of a State within Chanada: Any entity that wishes to separate from an existing state may not remain in

the union until formal admittance. That entity, must reapply to the Council of the Federation. If subsequently approved, the council of chan states will vote to accept the new nation.

The union of two entities within Chanada is permitted and only requires the negotiation of relevant representatives. No council vote is required outside of the internal affairs of both entities.
