

The HEH PILL OF RIGHTS

Formally, the Rules of Moderation For /b/ Owners & Users

The Owner(s) and Volunteers of the 8chan board /b/, along with the board /b/'s users, agree implicitly by their use of the board and its mechanisms that they will adhere to and respect the rules, rights, and consequences established by this list of ten points and contained within this document.

- 1) Moderators shall make no rules abridging either freedom of speech¹ or the right of the poster to peaceably ~~AAAAA~~Assemble. Nor shall they infringe upon the right to petition the moderator for a redress of grievances.
- 2) An unregulated environment, being necessary to the security of a free board, along with the right of the people to keep and bear Memes, shall not be infringed².
- 3) No thread limits shall, in time of peace³ be present, without the consent of the majority of the userbase; nor shall they be in the time of a board war, save for in a manner directed by the global rules.
- 4) The right of the people to be secure in their threads, against unreasonable locks and deletions, shall not be violated, and no Bans shall issue, but upon probable cause, supported by the Global Rules.
- 5) No person shall be held to answer⁴ for a capital or otherwise infamous rule violation unless on a presentment or indictment of a Moderator. Nor shall any poster be subject for the same offence to be twice put in jeopardy of lost posting privileges⁵; nor shall that poster be compelled, in any ban, to be a witness against himself⁶, nor be deprived of liberty without due process of the appeals system.
- 6) In all bans, the accused shall enjoy the right to an appeal, and to be⁷ informed of the nature and cause of the accusation; to be confronted with the evidence against him; to have the opportunity of presenting witnesses in his or her favor, and to have the right to Counsel.
- 7) The value of moderation, on the board of /b/, shall not exceed 0 (zero) dollars.
- 8) Excessively long bans shall not be imposed, nor cruel and unusual punishments inflicted.
- 9) The enumeration in the Heh Pill of Rights, of certain privileges, shall not be construed to deny or disparage others retained by the poster.
- 10) The powers not delegated to the Moderators by the Global Rules are reserved for the poster.
