# *An explanation of Doxing*

Now before I start teaching you methods of Doxing, we need to properly understand what Doxing truly is.

Doxing is essentially gathering information on a target or victim such as their home address, phone number, work place, school, full name, profiles, aliases, family members, and other personal data. We can do many things with this information, some which are legal and some which are not.

Some of the things are the following:

- Swatting (The act of calling a fake bomb/murder threat to the police with a victim's home address)
- Sharing the data (Posting information on public websites to allow your victim's other enemies gain the data and do as they please with it)
- Pizza delivery (Ordering a pizza to a victim's house)

There are of course many other things an individual can do with such data, but those are the most popular things that people do with their enemy's data. I wouldn't recommend doing anything illegal.

# *Basic information gathering/Getting started*

Now let's get started with actually Doxing. As I said earlier Doxing is essentially gathering information on an enemy/victim. To start Doxing, we need some information to start with.

Say our victim was "Xx\_Sniperpro\_xX" and all that we knew was (one) of his online alias(es) and his first name; John. What we would do to begin with is Google that exact alias and search through results, regardless of what type of website they are.

With that we would write down everything we found. That means any profiles, any friends, family, etc, or we could filter out his information by only using it if we know it is him.

Now this is something I can not be too specific with as everyone is different. You simply have to look around.

*Tip: When searching through forum profiles, filter out profiles that may not be his by look at the following:*

- *His post grammatical structure. If it is different than his normal grammatical structure, there's a good chance it's not him.*
- *Interests*

After we are done with what we can find on Google, we can move onto other search engines. Now here is one thing most people forget. Always write down any websites your target owns as they look good on a Dox and are nice to have, but they also often have contact data on them. You can throw that onto the Dox, and use it to get more data by contacting your victim.

Though modern sites with whois protection this will rarely work, you can also search through Whois data on whois record sites such as the following.

*Tip: Check the legitimacy of data such as addresses by searching them up on Google maps.*

Now that we are done gathering basic information, we can continue on by using tools to go into more detail with the data we have already found.

# **Detailed information gathering**

Now that we have unveiled basic information on our target, we can find more in depth information. To do this we use tools. One tool, which I personally use quite often, is <http://www.pipl.com/>.

Now assuming we have our target's full name, we can enter it there along with their location, again assuming we have it. If you do not have that information by now I would recommend you keep looking through forum posts and search engine results, and attempt to contact them and leak some information about them.

Anyway, from there we get a fair amount of information, which is very helpful.

We can also use a website called WhitePages (<http://www.whitepages.com/>) which is extremely helpful and very self explanatory.

Along with services on here, we can also use other data to our advantage to verify the data. For an example. Say we have our victim's IP address and ISP, we can 'ISP Dox' them. Now I do not take responsibility for any actions you take with this one, as it is very illegal and I am simply sharing the information. I would not use this. But, for education's sake, this is how an individual could do it.

Now unfortunately not many ISP's are vulnerable to this anymore, so this method is meant for Comcast, which doesn't always work. Anyway, here we go.

**Step 1:** Call Comcast. I would recommend using a free online phone service for this.

**Step 2:** Say something like the following: "Hello, my name is <victim's name> and I am calling as my land lord asked me to hit you guys' up and verify some information.

**Step 3:** Ask them to use the "GrandSlam" system to look up information using an IP address. Provide any extra information you have.

**Step 4:** Once they have your victim's account open, ask if they could verify the information for you. Provide them with the victim's name, phone number, and anything else of use. If they say it is incorrect, ask them if you could tell you what it currently is.

**Step 5:** Finish the call off by politely thanking them.

Now I must admit that I have never tried this method and I am not sure if it will still work. Again, I really wouldn't recommend ISP doxing in the first place.

Though you may already have social media, if you do not I would recommend searching various social media sites with their alias and full name.

Now sometimes manual social media searching isn't all that efficient, so I have listed some tools here for your convenience.

Now if we have the victim's phone number we can also phone them and ask "Hey. Is <victim's full name> here?" If they say yes or something along the lines of it, then we have verified the victim's full name. We can also get creative in many ways. I've heard stories of people taking the role of a concerned credit card company and asking if the user has been spending in some obscure country and then asking them to verify their full name and address.

Doxing is honestly about getting creative as every person is unique and so is every case.

We can also contact their school or work place. If you are a kid, then you can call up the school and ask for their phone number because you want to ask if your victim wants to have a sleep over, though unfortunately that won't go over so well for an adult or even a low voiced, adult sounding kid. If you are an adult you can make up the equivalent for a work place, though it is hard to give examples for those as all jobs are very different.

Again, Doxing is about getting creative, and no one can teach you how to Dox every person, though I am teaching you how to get creative and use your mind to do so.

# *Formatting*

Formatting your Dox is very important as it allows ease of use. Now you may or may not have been doing this the whole time, but if you haven't, your notes probably look something like the following:

Name is John Brown – usernames are Xx\_Sniperpro\_xX, xXSkydoesminecraft4lyfeXx, 1337hax17238  
facebook is [www.facebook.com/john.brown69](http://www.facebook.com/john.brown69) forum profiles <profile 1> <profile 2> <profile 3>

Now I am going to hope that you have more information than that, but that is just an example. What we want to do here is format your Dox so that it looks clean and is easy to use. Here is an example of a format:
