Accepted illegal campaign contributions from foreign citizens

Said he was "mad" over botched Obamacare website, but refused to fire anyone

Said "Don't believe what you've heard" regarding criticism of Obamacare

Signed health care reform that broke his promise not to increase taxes on families making less than \$250,000 a year

Signed so-called “hunger-free” act that left students feeling hungry

Signed health care reform that is so terrible that less than 3% of federal employees want to join it

Signed health care reform law whose own authors called it a “huge train wreck” that was “beyond comprehension”
