



The last Blood libel which happened in my home (Hungary) happened in 1998 during the jewish easter (Körmendi gyilkosság/Tánczos Gábor ügy), where an 11 year old girl was murdered in

her parents apartment. Her throat was sliced and strangely they didn't find any blood in her during the autopsy. Later the police jailed a 18 year old guy and he was sentenced for prison, Today it is widely believed that he was innocent. After the case this guy (pic 2yes he is the based hungarian mayor) wrote an article about his investigation and he concluded that the girl was most likely killed by a jewish religious zealout and her blood was stolen for blood rituals.

Our editor received an anonymous letter in which the writer of the letter tries to draw our attentiont towards a shocking murder nin years ago.

According to our reader, in 1998 the back then 11-year-old girl wasn't murdered by Tánczos Gábor

who still denies his involvment in the murder, but by Jews who at that time resided in the city.

After the "Mór case" they definitively showed that the Hungarian police are able to inprison anybody innocently during conceptual convictions we are not suprised by a lot of thing

but this accusation even suprised us. Although the case is so Körmend first hearing is quite similar to the 1882 Tiszaeszlár lawsuit. According to the so called Blood-bibel some jewish fundamentalist murder goy children during the jewish passover and use their blood for ritual purposes.

Despite the fact that the Blood-bibel sounds a little bit unbealiveable during the 2000-s our staff started investigating more so because the, letter writer said that he already sent

his letter to multiple news paper but none of them dared to do something with it.

As we kept digging we managed to uncover some really shocking, terrible in correspondence with the murder.

In spring 1998 the whole country was shocked by the news: Zsófi H., a 11-year-old girl was brutally murdered

at the family house in Körmend. The father found her dead body when he returned home from his work.

The killer followed Zsófi who is around five-thirty was on his way to home from school with his girlfriends,

she just jumped into the apartment only to drop her pack, and thento come back to the playground to her friends.

But Zsófi never returned. The killer went into her apartment through the door which she left open.

First, they struggled, the little girl tried to defend herself, but eventually the superior force of an adult

triumphed. He hit her head with a small statue he found inside the house. After the girl's body went limp,

the culprit is a sharp cutting tool, it certainly took a knife, and cut her neck ear to ear.

The method used by the killer point to a professional killer who still had enough presence to wash his hands

and knife in the bath and then leave undetected.

The day after the murder, a 18-year-old boy at the time, Tánczos Gabor went into the local bar where -as it was

throughout the country- the main topic was the murder. From there a while we pass the word Balaton Balazs,

who wrote a book about the case titled The Tánczos dossier. Dr. Laszlo Toth, Tánczos lawyers admit that

Balaton Balazs jpurnalists knows most about the case who first arrived at the murder scene, personally met and interviewed all stakeholders, from Zsófi parents, Tánczos Gabor, police investigators, the judge and jury.

first of all, here are the details Balázs Balaton's book, which explains how did the young man get involved with the case

whom most people think had nothing to do with the case and is nothing but a scapegoat.

"The police was still working on hot track when Tánczos Gábor went into the local bar at April 2. One of his

acquaintance works there, The lady also has a child about ten years old, and lives in the stairwell, where the murder occurred.

Gabor anxiously ask: is it not your daughter who was killed? The barmaid soothe her that it wasn't. Gabor says this:

he was in the area around the time of the murder, was in fact inside the stairwell, he visited one of his friends.

She advises him to tell the police what he knows, it might help the investigation. Without friends,

lived in solitude, always excluded the boy's eyes brighten up. He has a few friend. He has always had the attitude that

the globe will see, once I'll be a famous man, a hero! Now is your chance – thought! Crown witness in a murder!

Every guy will be anxious and all the girls of the city will like me. Later he goes to a policeman in civilian

clothes whom he knows a little. He explains: he was at the scene of the previous day's murder, he may be able to provide

information. He calls the station where they say to him: Send the witness.

Gabor voluntarily go into the station late in the afternoon. We have the first witness. They asked me to contribute

to apprehend the killer. The boy nods and tells what he saw: When I've got into the gate a man ran out from the house,

he seemed upset. I found it strange for a while, but I did not attach much importance to it. I went to my friend.

Sz. Gyuri whom I talked for ten or fifteen minutes. Gyuri was called, and then we headed down.

When I stopped to thread my shoes on the third floor, groaning, rattling sound was heard from the apartment below Gyuri's.

Before I left the house, I went home and I found out just this morning that what happened in the apartment -

first confession "Gabor.

Tánczos Gabor thus voluntarily reports to the police by a witness. On the one hand, it wants to help, on the other hand,

he wants to get attention. Well he got it though not the was he wanted. In any case, it is established on the basis of

the witnesses and Sz. Gyuri's confession that he was indeed in the house at the time the murder was committed.

Which means that he had like 10 minutes to remove the evidences, after that he went to his friend who lived right above

the little girl. In fact Sz.Guri recalled that Tánczos Gabor was completely relaxed and even cracked a few joke.

Yet after such a brutal murder even an assassin heart would beat faster, and his clothes definetly would have been bloody.

Not to mention that it is inconceivable that someone after such a murder would

jump up to the apartment above for a little chat with the familiar.

The 18-year-old young man is not a professional killer and family members and friends told us that -

quite literally - he could not hurt a fly, and was never punished as a child because he couldnlt tolerate

physical violence and aggression. The police made shocking mistakes from the begining, a few days later he became the prime

suspect from a witness. They were in a quite hurry because elections were coming.

Gábor Kuncze, who was minister of home department hastened to resolve the matter as soon as possible,

and the police, the investigating authorities appear to be trying to fulfill this.

They quickly claimed that the murder was Tánczos Gábor and Kuncze give away plenty of reward and promotion,

although they failed the election in spite of everything. Then it would have been particularly uncomfortable to admit that

an innocent young man was imprisoned, so everything was back the way it was.

Till this they the only thing that the police and jury has are those confessions that now been proven to be said under

pressure and beating, which he admitted due to his weak nature after the first hits, by the way he revoked these confessions

multiple time since he is in jail since he has been sentenced to 13 years in 1998. He probably will be released next year

after 10 years in prison. In fact, recently he said that move abroad after his release because he can not go on living here,

but first I want to find the real killer. Now, why would you say such things?

Now basically all the same to him anyway, because the penalty for murder, has ended almost entirely, his life is in ruins,

and he has been broken both physically and mentally. Balaton Balázs is convinced that in any case Tánczos is innocent,

and he says this in his book. The police and the court's work summary in his opinion:

"The facts that come to the surface after the murder already proved: there is no basis in reality what the cops say.

They made a fool out of themselves in front of the entire country but ostrich policy Continuing led to believe them:

excellent professionals who have managed to catch a murderer. "

It couldn't be heard much that Tánczos Gábor agreed to polygraph test (the cops accused of raping Zsanett didn't) and it showed

that Gábor didn't lie when he said he was innocent. Balaton Balázs writes in his book about the police several inexplicable

omission, deliberate error for example. According to the confession Dr. K. Katalin the doctor

who first came to the scene with the

ambulance: the apartment did not look like it has been reported by the police later. In fact, according to her memory the

little girl was in different clothing than what the official papers included. It is really just icing on the cake:

surely remember that the official had no witnesses leg nylon bag and later during the investigation this was a key issue.

Who and why let civilians inside the house without legprotection? Who lies about the little girl clothing and why?"

And there is also a very important issue for Tánczos: What was the motive? Because this is a question to which no one could give

a reassuring answer. If you can rule out sexual aberration or robbery, then why have he killed someone dear to everyone,

a cheerful child? In case of Tánczos or in any other suspect the police were incapable of giving an acceptable answer.

The locals asked by us and Balaton Balázs mentioned that the murder might have been an assassins who come to kill the daughter of

the neighbour businismenn but missed the house number. Balaton Balázs after realised the Gábor is innocent out of desperation

said that the father might have had a hand in the murder. However, both police and private investigation showed that both

assumptions is very far from the truth and completely unreal, not to mention the fact that it is inconceivable that

a father would murder his own daughter in such a manner. Tánczos parents and those who belived in his innocence accused

almost anyone who could be considered, but in reality the only thing they had are guesses, until now...

Acceptable explanation didnlt existed this far. Zsódi father H.Ferenc said the following when asked why would someone kill

his daughter? – I have no idea. Zsófi has harmed no one, everyone loved her. She was always

the leader of the class,

she attended religion classes, folk dancing and fencing, she was an excellent student. When asked, the school can only

say good things about her – said the father.

And here comes the surprising part: the blood-libel mentioned in the anonymous letter was the only motive that

we can not only couldn't refute during our investigation, but we could work towards further strengthening.

First of all let's examine what is known about allegations of blood-libel. For example that fact that a man who can hardly

been accused with antisemitism a Jewish history professor from Israel named Ariel Toaff published a book not so long ago in Italy

at the Il Mulino publisher called Pasqua di Sangue (the bloody passover). He claims in his book the blood-libel has a rational

base, Jews in the 11th century Germany started the practice by killing Christian children because they wanted to take revenge

on the Christians for the passing crusaders who started killing Jews. The blood obtained this way during Passover,

Seder evening closer, was mixed with wine and baked into matzah and served during the feast where they celebrated Exodus from Egypt.

An interesting detail to the book that the writer Ariel Toaff is the son of the Roman chief rabbi and also a rabbi himself.

He is also a professor of medieval and Renaissance history at Bar-Ilan University in Israel. The book was released in 2007 but shortly

after was ordered back and the author said he will rewrite it.

Soon it turned out that Ariel Toaff received death threats, and this, as well as the hate campaign against him was the result

that the author withdrew the book of their own. Before that Toaff said to the Jewish rabbis attacking him "these acts

were confined to a small extremist groups. Islam can not be condemned based on the activities of some extremist groups. The child murderer Jews were looking for revenge and redemption".

The most famous blood libel case in Hungary, which took place in 1882-83 was the "Tiszaeszlár case". Then a 14-year-old

Christian girl, Solymosi Eszter disappeared without a trace near the local synagogue in the town of Szabolcs.

The suspicion soon turned to local Jews where during the time stranger beggar Jews were camping.

Eszter's mother made an accusation against the Jews at the local authorities, but at first they only issued a national warrant.

Later however the 4 year old son of the synagogue caretaker on the football field blurted out to Christian playmates

that he and his brother, Schwarc Móricz saw through the keyhole, as 3 jew including their father ritually executed Solymosi Eszter

whom they had to lure into the synagouge. The 16-year-old Móricz was first reluctant to testify,

later he told the investigators everything. On the basis of this many jews were arrested. Further proof that the girl didn't

went missing as the jews claimed that months after the girl went missing local fisherman (who were jewish) fished out a girl

who weared the clothes of Eszter. Autopsy later concluded that the girl was a 20+ year old jewish prostitute who died in some sort of

lung disease. After news reached the country that the jews were released riots broke out throughout hungary, the suspected jews fled.

Later it was rumored the Rotchild family paid 60 million in order for them to be released, and many official said that jews were trying

to bribe them.

After all this let's look at the Childmurder at Körmend. Blood-libel can be ruled out if based on the time when it was convicted

because these acts are only committed during the Jewish Passover. The "Tiszaeszlár case" stands its place as a blood-libel

because Eszter disappeared at April 1. 1 day before Jewish Passover. Now hang on, dear readers:

H. Zsófi was murdered 116 years later the same day, April 1.

There is another method which we can exclude the possibility of blood-libel, the method. Because the goal of the blood-libel

to remove the blood of the victim so they can use it in food and wine later, according to descriptions these murders

are done by Jewish shochet. Shochet is the person who kills the animals in the Jewish household by slicing their

neck from ear to ear, running off the animal blood in the process. The crown witness in the "Tiszaeszlár case" Schwarc Móricz

claimed that Eszter's throat was sliced by the Shochet with a sharp knife. In case of the "Körmend childmurder" we can conclude this

quite easily because we have the corpse so we can rely on the medical reports.

They clearly state that Zsófi's neck was cut from ear to ear with a sharp object, probably a knife. If Tánczos Gábor kills here he

probably have done it with passion and stabs her multiple times. Last year happened a similar case at Zombó where a 17 year old insane

girl murdered her brother. And she didn't cut his throat but stabbed him 70(!) times. Zsófi on the other hand were killed professionally.

First she was beaten into unconsciousness and then her throat was cut from ear to ear and then he let her bleed to death.

Investigating the method we can claim that it didn't exclude the suspicion of the blood-libel,

but on the contrary, it is becoming a certainty.

During our extensive investigations we went the terrible murder scene as well. However none of the interviewed locals have heard about

the possibility of blood-libel committed by jews. But they all agreed the Tánczos was an unlucky harmless pushover who was used as

a scapegoat by the police and the court. Although on Kőrmend we haven't found anyone who dared or could said anything about the

jewish blood-libel we managed to do it on the internet. On the site suttog6.hu (whisperer) a user named Aakum said the

following.

"The oddities of case that the day the murder happened there was a large number of Hasidic Jews in the city who came here

on buses with foreign registration numbers. According to the testimony of Tánczos he saw a guy in black clothes and long beard

leave the house. Because he was the only witness he had to take the blame. An other interesting fact that the cops unusually high

numbers for a murder case and not local cops but cops from Szombathely (a jewish town in Hungary) lead by a jewish cop whose

lastname was Farkas (I can't recall his rank). The throat of the girl was sliced with a so called Schohetslice (ear to ear) which

caused a large blood loss in a short time. Of course nobody was arrested from the jewish tourists who visited the city that day

they left the country the same day and together with them the details and secrets of the murder too. I heard these details in

1998 from a guy who works at the BM (ministry for home affairs). (I've still have his name and address). I wrote it down back then

and sent it to a newspaper which works in immigration, but sadly they didn't publish it (maybe they didn't get it).

I wrote it down from memory, after 10 years the details start to fade... What I can still recall that Zsófi's father was a hunter

and he kept his gun home. It was obvious to him that Tánczos had nothing to do with the murder he tried to hunt down some jews

around the neighbourhood. The police immediately took his gun away and he was moved at the

other side of the country.”

Of course the author of these lines also were contacted, we will show you what we managed to find out in our next issue.

We will continue our investigation and we will travel to the other side of the country to see Zsófi's parents who moved away

from Kőrmend and disappeared from public view. We will also contact the journalist Balaton Balázs who in 1999 may, was beaten

by a bunch of men who got out from a police car after saying to him “It will be best if you stay quiet!”.

Balaton Balázs suffered serious damage to health, and, of course, denounced the attackers, and since it was likely to be policemen, the prosecutor's office investigators took over the case.

I expect our readers had not even been surprised when we tell that in September 1999, the investigation was closed under

the guise of “unknown perpetrator”. The interesting thing that after this that the personal protection of Balázs was

taken care of by the In-Kal security which is known for its Israeli connections.

From the next issue it will be revealed that, there was really a black haired stranger who followed Zsófi before the murder.

On top of that the police looked for a blackhaired man after the murder, so much in fact that the police did a day long raid in

the local gypsy ghetto. Police also find a black hair string in the closed fist of Zsófi after the murder.

As we promised in our last issue we will continue our investigation in relation to the horrific murder nine years ago.

Our articles found a great echo, readers help to spread it throughout the internet and even physical copies.

Family members, journalists and experts who we sought, know about the article before our

arrival. We have no doubt

about that, that those who know or suspect what happened at Körmen on 1998 April 1. also read our article.

Knowing all of this it's interesting that the mainstream media in Hungary decided to stay silent on the possibility

proposed by our article. It's even stranger that the media still reports on the murder after 9 years it happened.

Of course we pretend to be naive, because we know from experience that when the word Jew comes up people start

to whisper, and they engage in some sort of self-censor. Our staff didn't care about this of course, we care about

the truth.

In the previous issue, we promised that we visit Balaton Balázs, who is the most knowledgeable man in connection

to the murder. I managed to track him down, and I met him on the terrace of a cafe in Buda. We knew

each other because we were classmates in college, so - although he did not know specifically why I'm looking for him -

he started talking easily. He wrote a book about the case and the trial named Tánczos dossier.

Seated throughout the parley, and spoke to all the players arrived to the scene of the crime.

Balázs Balatoni said that since two years ago he no longer deals with the matter so intensively,

Gabor released soon anyway, these days do not even visit him in prison, whereas previously visited him regularly.

When he knew that I'm here because of the possibility of the blood-libel, he said that he also got the anonymous letter

as most of the journalists who reported on the case, but no one wanted to investigate that way.

Of course nothing surprising about this, today Balaton Balázs became a district council press officer.

There are still things in Hungary today which are advised not to comment on such a position, it soon

became clear that no one dares to speak about the issue. An expert who I visited during the investigation

asked me to let him(?) remain anonymous and in exchange he grants me access to the court and police files.

Where is the blood?

Let's look at what facts do these files have in them. Below you can read verbatim quotations from the documents:

"It was recorded in the autopsy records that, the dead wore a farmer, the farmer was buttoned it was unzipped.

Inside the farmer right under the genitalia we found a 40 cm hair string which was longer and darker than the hair

of the dead. We recorded this clue under the number 18." The anonymous letter stated that the hair string might have gotten

there, because before ritual murder it had to be sure that, the victim is virgin.

The Supreme Court's documentation on regard to the hair string: "The 1/3. Volume, page 401 and 409:

according to experts 44 cm side length of 75 microns wide string on the child victim's legs original color is grey-brown.

The investigation found that the hair color and structure did not match with the hair of Tanczos Gábor."

During the autopsy they recorded the following: "on the left hand of corpse, on the pointer and ring finger we found fibers.

We removed those and keep them in glass vials(clue number 13). on the right hand of corpse, on the thumb and pinky we found fibers.

We take nail scraping from the left hand (clue number 16) We removed those and keep them in glass vials(clue number 18).

We take nail scrapping from the right hand (clue number 21).

Well these undoubtedly crucial clues when examined, showed that the DNA did not belong to Tánczos, but then who do they belonged to?

Morover they couldn't find his Dna nowhere on the scene. However they found foreign fingerprits and earprints on the scene, which

aslo don't belong to Tánczos. But to who do these belong? And who owns the long hair string if not him? In the recent years it was

reported that Zsófi's friend who was a few years olden than her Zsódi said days before the murder that a strange man has been

following him. Szilvia (Zsófi's girlfriend) said the followng:

-When did Zsófi showed you the man who followed her?

-I do not remember exactly 1 or 2 weeks before her death.

-We went into the store next to their house. I think I wanted to buy some chocolate. We walked in the shop

when she leaned over to me and pointed to a man. - "He followed me for days" - she said.

-Did you go to him and ask him what di he want?

-No first I thought it was one of Zsófi's whim. Time and again she said something that should not be taken seriously. She said a lot

of jokes. I thought it was one of theese, but i now i know she was serious.

-What makes you think so?

-Zsófi has changed in the days before his death. She was scared. We noticed that she was not laughing, and her humor is gone completely."

When Gabor Tánczos volunteered to the police as a witness, in his statement, he said that a man ran outside the apartment when

he got there. He also give a description about the guy. According to this the guy was probalby not from körmend, not even from hungary.

He said that he was a "Mediterran looking guy". That's why the police did a day long raid at the local gypsy ghetto. But under

Mediterranians we don't mean gypsy, but rather Turks, Greeks, Italians and Israelis. After Tánczos Gabor was arrested the police did not

seek further the Mediterranean-looking man, nor did the court, even though the defense has two workers who worked at the time at the

apartment, and they also saw a Mediterranean looking guy leave. The most important thing in relation to the murder is the case of blood.

Every expert who was involved and spoke with us confirmed the same thing. There was no blood on the crime scene. There was a small

blood string at the neck of the victim. Liters of blood were simply missing.

The investigators haven't found any blood on the clothes of Tánczos aside from 2 drops which later turned out to be his own from a kitchen

accident. According to the autopsy the reason of death is blood loss.

However, in this case, several liters of blood had to flow out! According to experts, the culprit shut the mouth and nostrils

before he cut the neck and continued to do so after.

According to the autopsy they found small nodules on the body of the girl which point to the loss of oxygen. In these cases

the crime scene should have been swarmed in blood. According to the police Zsófi was found on the sofa with his head hanging down from

it. According to experts there should have been liters of blood at the crime scene. The investigators searched for traces of

blood in the apartment with a method called Luminol procedure finding nothing!

There is only one possible explanation why did they not find any blood on the scene. Because the murderer flowed the blood into a vessel.

It is supported by the fact that the murderer didn't stab the girl only shut his mouth and nostrils and waited until she bled to death.

Surprisingly familiar police officers

As indicated in our previous issue we contacted the user on Suttogó.hu. We exchanged several letters, it turned out that this BM

(ministry for home affairs) officer, from whom he first heard about the blood-libel in 1998 was a friend of his friend. He tried to

make contact with him but he didn't succeed in this 2 weeks. We only got his description and the address of the house where he used to

live. So instead we tried to check the information he said. It turned out that the Zsófi's father was really a hunter but did he tried

to hunt down some jews out of desperation is unknown to us, but everyone who we asked said that it's unlikely.

But it is true that he moved from the scene of the crime, but not to "the other side of the country" only one of the villages

around Körmend. The poster said that his BM-informers mention that there was a jewish policeman with "Farkas"

surname who was involved in the investigation.

It's really important from the perspective of trustworthiness of the post, for this piece of information to be true because it's

a factual one. After we looked into this it turns out that there was indeed a police officer with the surname Farkas involved in the case

namely Farkas István. We asked Tánczos mother and she remembered that a police named like this investigated in connection to the murder,

and not in any position, he was the guy who recorded the clues, so in connection to the investigation he was responsible for the most

important thing. Lieutenant Colonel Farkas István is really liked by the left-liberal government because Lamperth Mónika minister

of home affairs promoted him at the same time as Gergényi Péter.

>Gergényi Péter was the chief police who ordered the so called Police-terror on 2006 oktober. 23.

where they attacked people who opposed the Left-lib government back then.

This year, on March 15 the Gyurcsány-government honored Farkas István with the high cross of the hungarian republic.

Aside from that fact, that a police officer who said to us that he thinks its possible for Farkas István to be a jew

we find no evidence that he is one. But if we type "Farkas István" into the google the first page that will pop up is

the wikipedia page of a Jewish painter who died in Auschwitz.

And speaking about the police, its interesting to note that during the murder the local county police chief was Bene László,

the guy who got infamous during the 2006 police terror as one of the leader of the ORFK.

>ORFK is the organistaion which controls the police.

Bene László Outstanding career is a result of arresting Tánczos Gábor. Because the mured happened during the 1998 elections

where the MSZP-SZDSZ governemnt (MSZP is the post communist part, SZDSZ is an already non existent liberal party) fund it

extremley uncomfortable especiall in that climate where it was daily event that the Mafia bombed something in relation to politicians.

So in order to calm the people they had to find the cupltrict before the elections.

So the local police did everything it could and they arrested the only witness they had back than who was Tánczos Gábor

Bene László was promoted the day after the arrest from a county high chief into a police general by the president Göncz Árpád.

Then the Minister of Home affairs Kuncze Gábor goes to the scene of the crime and start handing out honorariums to those cops,

who take part in the investigation. On April 30rd Kuncze Gábor and Bene László take part in a press conference, in which they

state that according to the confessions and proof they gatherreed it's very likely that Tánczos Gábor was the cupltrit.

They had to hurry because the elections were held at may 10th, so they needed results at any cost. It turned since than

that the authorities had literally no proof against Tánczos, and Tánczos revoked his confessions which – according to a medical

expert – was made under the influence of drugs (Xanax and Dormicum) and was forced through beatings. The boy stayed in prison

but Bene László managed to climb police rank ladder ever since.

During the first Orbán government Bene didn't advance in the ranks and the high court restarted the case. But those who thought

Tánczos was innocent had false hopes because during the Orbán government he was sentenced again. We know from his family

that he voted the Fidesz (the party of Orbán Viktor).

After the 2002 elections Bene's career took off again, he became the head of the BM Law Enforcement Agencies Protective Service

and the same year he received central officer title from the D-209 prime minister Medgyessy Peter.

In 2006 he was already the high chief of the country, and he was one of the prime organisers of the 2006 police terror.

In 2007 because of the general hatred of the public towards him Gyurcsán Ferenc was forced to replace him together with Gergényi

Péter. But it seems that the current government likes him for some reason he became the state secretary for police affairs,

it's rare from a police officer to fall upwards.

That's just icing on the cake that the Kőrmend apartment where Zsófi killed following the murder Lieutenant Colonel Marks Attila border

guards moved in, and he didn't allow that after the investigation, with the participation of Tánczos Gabor

reconstruct the murder, so that they can prevent the undoubted contradictions he revealed on the site.

9 years, I saw heart medicine in her pack. His son in the prison got epilepsy and they find cysts in his brain-

probably from the beatings. She shows me his son's photo as a baby and says the murder was the tragedy of 2 kids his son

and Zsófi. One of them had been killed the other had his life broken in two. She also heard about the version of

the blood libel, as everyone who had something to do with the case she also got the anonymous letter.

She doesn't want to talk about this, she fears for her son who as she says "still in their hands".

She also fears for her 80 year old dad, but she has no concern for herself - I've only got 1 thing in life and

that is to prove my son's innocence.

Bene László was promoted the day after the arrest from a county high chief into a police general by the president Göncz Árpád.

Then the Minister of Home Affairs Kuncze Gábor goes to the scene of the crime and starts handing out honorariums to those cops,

who take part in the investigation. On April 30th Kuncze Gábor and Bene László take part in a press conference, in which they

claimed that Tánczos was innocent was also beaten.

But they even managed to scare the local bouncer who claimed that Tánczos was innocent, but he's only willing to do testimony if he

gets police protection, because in this matter very dark forces are interested.

We spoke for hours at the Batthyány family obelisk while walking past many children and adults but everyone was kind to her.

Typical about the locals' attitude that they all think that Tánczos is innocent, the only reason they could keep their house after

the court demanded them to pay for the suit, because no one went to the auction where they

wanted to sell the house.

Back to our investigation in relation with the blood libel, when I was at Körmend more than 1 question occurred to me.

I sought out the Jewish cemetery, I took some pictures but I haven't found a single caretaker or relative among the graves.

I think it is important to point out for the sake of objectivity that every available study from Jewish historians among other

things – like the book *Pasqua di Sangue* (Bloody Easter) was mentioned in the previous issue –

says that the only fundamental Jews did such deeds. But where can you find today such fundamental Jews in this county?

The previously mentioned book claims that these Jews are the Hasidic ones but they barely have any presence in Hungary and certainly

not in this county.

The Jews weren't allowed to settle at Szombathely till the nineteenth century aside from the Batthyány lands.

After all Körmend belonged to the Batthyánys, it is understandable that the rural Jewish community was one of the most developed here.

In 1888, they built a synagogue in the center of Körmend, however later it was used as a storage in World War 2 by the Hungarian-German

soldiers, who burned the building when they retreated. In its place we can find a monument with the names of the Jews who were

deported. So it is understandable that Jewish tourists who visit this county would visit Körmend. And it would be part of the motivation

for revenge because not only the local Jews were deported but the synagogue was burned. But why this county? In this article I will

reveal that fundamental Jews were present at Körmend at the time of the murder.

After I left the park and said goodbye to Tánczos Mother I looked back, because it's already a reflex in me to look back,

I noticed that a white car veered off the street after me. After approx. One hundred meters you'll turn right and down the street

there stands the Catholic church tower. In the mirror I could see that the car come after me here as well.

I parked in front of the main entrance of the temple, made the sign of the cross then went into the temple garden.

Inside there was a wooden cross with Jesus under it the text "Let's remember Zsófi".

After I went around the temple I saw that as the white car stopped at the temple. I returned to my car and got inside and I recalled

that I had to call one of my colleagues. As I finished a man came to the window and said the following:

-I know why are you here. You have to search around the Traubisoda.

I wanted to ask him things but he just walked away as fast as he could.

Although I have been many times in my life Körmend, the city is full of friends and acquaintances, but now I felt that it is better

to leave the town behind me. The overwhelming feeling somewhere in my stomach tightening began to dissolve around Veszprem.

When I first heard the name at Körmend, I knew that he was the Traubisoda-maker, who became infamous because of his very
